Final development plan review process (Crook County Code – 18.116.110).

The planning commission shall review a final development plan. The planning commission shall approve a final development plan if it conforms to the approved development plan and its conditions of approval.

BURDEN OF PROOF STATEMENT MUST ADDRESS THE APPROVAL

CRITERIA IN CROOK COUNTY CODE 18.116.100.

The applicant must demonstrate the following:

The final development plan conforms to the approved development plan and addresses all conditions of approval of the development plan, including any approved modifications to the development plan. The applicant must demonstrate that the final development plan is not materially different that the approved development plan. If the planning commission finds that the final development plan is materially different from the approved development plan, the applicant shall submit an amended development plan for review. "Materially different," as used in this subsection, means a change in the type, scale, location, or other characteristics of the proposed development such that findings of fact on which the original approval was based would be materially affected.

In demonstrating that the final development plan is not materially different that the approved development plan, the applicant shall demonstrate the provision of infrastructure (water, sewer, transportation) can reasonably serve the destination resort in a manner that conforms to the approved development plan (either original or as modified).

The applicant must demonstrate that the final development plan addresses all conditions of approval of the development plan.
