Re: Conversion of CC Road Department from Kenwood NXDN to MOTOTRBO subscriber units.

Per our discussion, upon approval, Prineville IT will furnish and install the following radio equipment for the Crook County road department in accordance with our existing radio system repair and maintenance IGA:

55 mobile radios (model XPR550E). 49 radios installed in equipment, 5 base stations and 1 spare. (Base stations may substituted for desk sets and single control station if available from manufacturer). Installations will re-use buck/boost converters, existing antenna systems, roof/firewall penetrations and cabling where appropriate.

55 Mobile/base radios furnished and installed: **\$48,125.00**

15 portable radios (model XPR7550E). Includes 1 multi-unit desktop charger and individual single unit chargers.

15 Portable radios furnished and installed: **\$14,743.85**

All equipment will be programmed to the Crook County Public Safety template, with a dedicated, repeated channel provided for Crook County Roads, and a simplex "direct" channel available for exclusive road department use. Roads channel will be added to the emergency dispatch console, and interop channels with Crook County Sheriff's office will be programmed as necessary.

Hardware has an expected lead time of 6-12 weeks, and is subject to supply chain delays. Trade-in and decommissioning of existing Kenwood NXDN equipment is included in this pricing.

Total Project cost: **\$62,868.85**
