RE: Request to purchase two vehicles for building inspectors

To improve its vehicle fleet, the Building Department plans to acquire two new vehicles. We currently have 11 inspectors who drive an average of 1,123 miles per month. Our fleet includes seven vehicles with over 100,000 miles. To ensure we have reliable vehicles for our inspectors, it is important to add new fleet vehicles and retire old vehicles.

We requested quotes for two Ford Rangers 4x4 C/C CL models. Attached are the quotes from three area dealers (Exhibit A). The lowest price is \$27,967.85 from Wright Ford in Bend. The other bids came in higher than \$29,000.

The combined budgets of the Building and Electrical divisions have over \$66,000 set aside for the purchase two vehicles during this fiscal year. Accordingly, this expense was budgeted, and the funds are available.

The Department recommends accepting the low bid for the two fleet vehicles through Wright Ford.
