Motion

Commissioner Brummer moved to approve the Consent Agenda as presented. Commissioner Barney seconded the motion. The vote was 3-0, motion carried.

Swearing-In Ceremony of two Patrol deputies: Leo McKenna and Jason Weber

Crook County Sheriff presented background information on two new Sheriff's Deputies and presented their Oaths of Office. Deputy McKenna and Deputy Weber received their Oaths of Office, introduced their families and were issued their challenge coins.

Presentation of quotes for new vehicle, Crook County Community Development

Commissioner Brummer provided three quotes gathered by Community Development for a new vehicle to be used by the inspectors. Quotes were received from TS&S, Wright Ford and Robberson Ford. The low quote is from Robberson at \$25,850 for a Ford Edge, Black and on the lot. Recommendation was made to award the purchase to Robberson Ford.

Motion

Commissioner Brummer moved to award the purchase of the new vehicle for the Community Development Department to Robberson Ford at \$25,950. Commissioner Barney seconded the motion. The vote was 3-0, motion carried.

The Court discussed the need for additional vehicles for the department and thanked Mr. Wilson for his work at finishing the documents for the purchase so rapidly.
