**BE IT REMEMBERED THAT** the Crook County Court met in a regularly scheduled meeting on April 18, 2018 at 9:00 a.m. in the County meeting room located at 320 NE Court Street, Prineville, Oregon 97754. In attendance were: County Judge Seth Crawford; County Commissioner Jerry Brummer; County Commissioner Brian Barney; County Counsel Jeff Wilson; Assistant County Counsel Eric Blaine and County Court Secretary Colleen Ferguson.

Judge Crawford called the meeting to order and asked MaryLou Bernard to lead the Pledge of Allegiance.

Rory Rodger provided the invocation. He was accompanied by his family to the Court Session.

#### **Resource Sharing Agreement with Deschutes Public Library**

Cindy York, County Library Operations Manager, presented a proposed cost schedule and explained the sharing and carrier service involved in a shared program with Deschutes County. This agreement does not require obtaining three bids. This resulted in an increase of \$587.00 last year.

#### Motion

Commissioner Barney moved to approve the proposed sharing agreement. Commissioner Brummer seconded the motion. The vote was 3-0, motion carried.

# Public Hearing, Ordinance 306, amending Title 18 and the Comprehensive Plan and declaring an emergency, 1<sup>st</sup> reading, removal of Ordinance 259

Asst. County Counsel presented Ordinance 306 and the remand of Ordinance 259. This ordinance will address the importance of why and how Ordinance 259 was implemented, and memorialized the remand and changes. This will be change to the code and comprehensive Plan, and will go into effect June 16, 2018, 180 days after the LUBA Remand.

Judge Crawford presented an overview of the two years of employee's time taken and then the State contesting the plan. Now, the law will revert back to what was in place prior to ordinance 259's adoption in December of 2012. The Court feels this is a sad day and the end result of many years of work.

#### Motion

Commissioner Brummer moved to read Ordinance 306 by title only. Seconded by Commissioner Barney. Vote was 3-0, motion carried.

Judge Crawford read Ordinance 306 by title only and opened the Public Hearing. There being no comments received, Judge Crawford closed the public hearing.

The next reading will be at the May 2, 2018 County Court meeting.

#### New employee, Health Department.

County Roadmaster Bob O'Neal announced that the Millican Road job paperwork was now final and worked out well. The County saved \$187,000. Mr. O'Neal, Jeff Wilson and Kathy Gray worked together as a team on the project and retained a great relationship with ODOT through the process.

At this time, there being no other items before the Court requiring action, Judge Crawford adjourned the Court out of Open Session and into Executive Session under 192.660(2)(e).

# Executive Session under 192.660(2)(e) for the purpose of conducting deliberations with persons designated by the governing body to negotiate real property transactions

The Court and County Counsel met to discuss a property lease. Following the discussion, Judge Crawford adjourned the Court out of Executive Session and back into Open Session, inviting all members of the public waiting back into the meeting room.

### **Open Session**

Judge Crawford convened the Court into Open Session following an Executive Session under 192.660(2)(e) for the purpose of conducting deliberations with persons designated by the governing body to negotiate real property transactions.

### Motion

Commissioner Brummer moved to instruct staff to continue negotiation with Verizon Wireless as discussed in Executive Session. Commissioner Barney seconded the motion. Vote was 3-0, motion carried.

There being no further business before the Court requiring action at this time, Judge Crawford adjourned the meeting.
