### **ITEMS FOR REVIEW**

#### Final Plat Review of Grandview Subdivision Phase 2

Van Vactor also addressed the condition related to the lots being in accordance with the Fire Ready handbook. He stated that the standards are addressed in the CC&R's for the subdivision, and the condition is satisfied.

He also stated that the roads have been constructed, and the road improvement agreement has been signed by all parties.

Commissioner Stec made note that the applicant talked to her before the meeting and stated that he would be handing out the Fire Ready Handbook with the sale of each lot.
