#### **PUBLIC HEARING**

Continuation for deliberations only of Conditional Use Request, record number 217-21-000573-PLNG,
Robert Vanier Jr. and Lani Vanier (owners/applicants) – Conditional use approval for aggregate mining
operations on the property. The property is identified as Township 14 South, Range 15 East, WM,
Section 14, tax lot 103. The property is zoned Exclusive Farm Use – Prineville Valley and Lone Pine
Areas (EFU-2) and is located at the corner of Stahancyk Lane and Lamonta Road.

Chair warren stated that the conditional use permit request 217-21-000573-PLNG was previously heard by the Planning Commission on July 28, 2021, August 27, 2021, and was continued at the September 22, 2021, then to October 27, then to this hearing for deliberation only. File no. 217-21-00537-PLNG was heard initially along with a request to amend the Crook County Comprehensive Plan, File No. 217-21-000436-PLNG to add the subject property to the County's inventory of significant aggregate sites.

Chair Warren then stated that at the September 22, 2021, hearing, the Planning Commission made a recommendation to the County Court on File No. 217-21-000436-PLNG (the comprehensive plan amendment) but upon staff's recommendation, continued the conditional use permit until this hearing, in the hope that the County Court would have made its final decision on the comprehensive plan before proceeding with the conditional use permit.

Chair Warren also stated that the County Court is still processing the comprehensive plan amendment, and therefore, staff is recommending that deliberations on the conditional use permit be continued again, to a date and time certain in the future, so that the County Court can take final action on the comprehensive plan amendment.

Chair Warren read the opening statements and asked the commissioners if they had any Ex Parte Contact, Conflict of Interest, Bias:

Commissioner Pro Tem Weberg stated that he respectfully abstains since he was approached by members of the public after the meeting, influencing his bias.

The Chair then asked if any member of the public, including those participating by phone, wished to challenge any member of the Commission. No members of the public stated a challenge.

Chair Warren then polled the Commissioners to see if there were any questions regarding staff's recommendation for the continuation:

Commissioner Hermreck asked what date the meeting would be rescheduled scheduled.

Van Vactor responded stating that the continuation is scheduled for January 12, 2022, so long as there are no delays. He goes on to state that he has concerns the County Court will not have a decision by that date, and recommended canceling the deliberations for January 12, and instead hold the hearing on January 19, 2022.

Chair Warren stated that he would not be available for January 19. There was further discussion amongst the commissioners regarding availability.

Van Vactor gave a couple options, and the commissioners felt comfortable with moving the deliberations to January 19.

Commissioner Hermreck made a motion to continue 217-21-000573-PLNG Conditional Use Permit to January 19, 2022, at 4:00pm. Commissioner Stec seconded the motion.
