1. **217-23-000252-PLNG** - A public hearing before the Crook County Planning Commission for a comprehensive plan amendment, initiated by the County Court through Ordinance 337; the properties are identified as map/tax lots: 1515170000100, 1515170000106, 1515170000109, & 1515170000110. Proposed Ordinance No. 337 is an ordinance amending the Crook County zoning map and comprehensive plan to remove certain property from the destination resort overlay zone (eligibility map). If a property or properties are removed from the overlay zone, destination resort uses as described in Statewide Planning Goal 8, ORS 197, Oregon Administrative Rule 660, and Crook County Code Title 18, will be prohibited on those properties
