Record Number 217-24-000293-PLNG: Continuation for Deliberations only of Conditional use application for a photovoltaic (pv) solar power generation facility located on property zoned Exclusive Farm Use zone, EFU-3. The proposal includes a ground mounted solar array, gen tie transmission lines, a substation, an energy storage system, and an operation and maintenance facility. The project is proposed to be a 320-acre site, on a portion of property identified as map tax lot: 1615000000300. It is north of an existing solar facility.

The hearing is being held pursuant to Crook County Code (CCC) 18.172 Administration Provisions

The application is subject to review under CCC, Title 18, Chapter 16, Chapter 160, Chapter 161, Chapter 180, the Crook County Comprehensive Plan, Oregon Administrative Rules, and Oregon Revised Statutes.
