This site currently doesn't have any active violations or complaints, although we did receive a complaint Tuesday regarding fugitive dust and blasting, we have regulatory authority over neither and helped them with contact info for the county/DEQ for the fugitive dust. It's important to note that **we do not have a valid permittee for this site**. Richard L. Bartels is still the listed "current" permittee, but we are aware that he has passed away as of April 2023. The operator has been notified multiple times that a transfer needs to occur to keep operating but we have yet to receive an application. 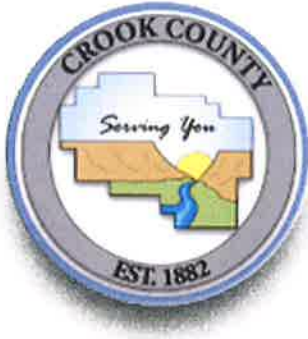
