Were annual reports provided to the Planning Commission regarding the number of days of operation, as required in condition number 6 of Conditional Use 217-15-000236-PLNG?

Answer: No. No record of any such reports have been found.

Was land use approval or building permits issued or inspected for the building indicated in the imagery provided in your written testimony exhibit (Exhibit 4)?

Answer: No such land use approval or building permits were found. An electrical permit was pulled in 2018 (217-18-002068-ELEC) for circuits for four yard lights outside shop. The permit expired and no inspections took place.

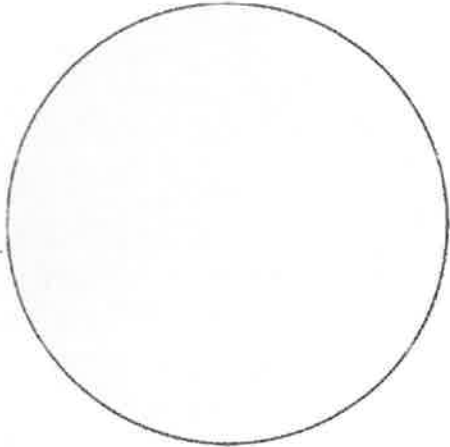
