Review of applicants to fill vacancy and reappointments.

Senior Planner, Katie McDonald, presented the process and the following:

In 2022 the Board of Commissioners issued 2022-52 which formalized procedure for appointments to boards. One of the requirements is the list of County Committees on the website, which has an application form. The vacancy needs to be advertised for a minimum of 30 days. The open position was posted November 7<sup>th</sup>, with an application deadline of December 16<sup>th</sup>. There are three commissioner positions and a pro-tem position that are expiring December 31, 2024. Four applications were received and date stamped prior to December 16, 2024. Of the four positions currently expiring, three commissioners have reapplied. There is a fully open position, position 4. The order is very specific on process.

County Manager, Will Van Vactor, discussed the importance of fair processes for the public. The commissioners up for reappointment need to recuse themselves from the interview process for other candidates, however interviews are not required. He asked Commissioner Dill and Commissioner Duncan to recuse themselves from the discussion of other candidates, as they have applied for reappointment.

Commissioner Dill recused herself and stepped away from the dais.

Commissioner Duncan recused himself and stepped away from the dais.
